The receipt of an entry implies the entrant's agreement to all conditions set forth in this prospectus.

#### **SPECIFICATIONS:**

The exhibition will consist of two-and three-dimensional work in all media. Wall pieces must be wired for hanging, maximum 60" high by 60" wide. Free-standing pieces may not exceed 32" X 48" X 60" and/or weigh more than 75 lbs. Accepted artwork cannot be substituted and must be available for the duration of the exhibit.

## SUBMISSION:

Submit up to three JPEG digital images only on a CD or via our website, **www.ccabedminster.org.** Images should be no larger than 1200 pixels in either direction at 300 dpi.

The Center for Contemporary Art has the right to exclude/refuse any entries which do not meet these specifications. CDs will be returned if a SASE is provided.
