### REQUIREMENTS:

Entry must be original artwork, wired, ready to hang, and acceptably framed. Clip frames are not acceptable. Maximum framed size permitted is 30" horizontally. No wet work will be accepted. Sculptors may provide their own pedestals or use CCA's which measure 18" x 18" x 40" high. Sculpture may not exceed 15 lbs. If your work requires special mounting for display please discuss with CCA prior to delivery. Work previously exhibited in CCA shows may not be submitted.

**Artwork must be labeled with name on the back.**

### ELIGIBILITY:

Paid-up membership through **September 2016** is required. Dues may be paid with entry. New members are welcome to join and enter at the same time. Entrants must be 18 years and older.

### JUDGES:

**Serena Bocchino** is a New Jersey artist whose themes include the visual interpretations of American jazz. Bocchino has a Masters Degree from New York University and has received acknowledgment from many institutions, including New York City's Artists Space, P.S. 1 Contemporary Art Center and the Museum of Modern Art.

### AWARDS:

Sally Bush Memorial Award (\$250); One Best of Show Award (\$150); two Awards of Excellence (\$50 each); and three Honorable Mentions

### SALES:

CCA will handle all sales, charging 30% commission.
